



Dual Enrollment (DE) Eligibility Requirements:

- Currently enrolled at a Lake or Sumter County school
- Un-weighted 3.0 high school GPA
- Complete at least two (2) high school-level classes with a passing grade (HOPE credit not eligible)
- Qualifying Test scores (*Test scores must be less than two years old and may be mixed for eligibility purposes.*)
 - **SAT:** Reading and Writing 490, Mathematics 480
 - **ACT:** Reading 19, English 17, and Math 19
 - **PERT:** Reading 106, English 103, Math 114
 - **CLT:** Reading and Writing 38 combined, Math 16
- Submit DE application by/before published deadline on the LSSC [Academic Calendar](#) page

Steps to enroll:

- 1. Qualify with eligible test scores or complete [placement testing](#) meeting the minimum scores listed above.
- 2. Submit the [Dual Enrollment Application](#) providing the following supporting documentation:
 - a. GPA and 2 HS-class Verification through Transcript (*Public, Private, and Charter school students*)
 - b. Proof of Qualifying Test Scores through Transcript (*All students*)
 - c. Proof of alternative credit such as AP or IB through Transcript, if applicable (*All students*)
 - d. Home Education Verification Form (*Home Education students only*)
 - e. Signed Dual Enrollment Home Education Agreement (*Home Education students only*)
- 3. Check email for an LSSC Acceptance Letter that provides your XID and Lakehawk Email
- 4. Once accepted, log into your [LakeHawk account](#) and LSSC email as instructed in the acceptance letter.
- 5. Schedule your New Student Advising and Registration (NSAR) Orientation using the link in your LSSC email.
- 6. Once Orientation is complete and your hold is removed, you may register for classes before the deadline.
Classes are not finalized until School Counselor and LSSC DE Advisor approve courses.
- 7. Students should arrange to pick up textbooks and supplies for classes.
 - a. Public School Students- Lake County
 - i. Lake County Textbook pick-up location: 509 S. Palm Ave. Howey-in-the-Hills
 - ii. Contact Lake County Schools at 352-253-6770 with any questions.
 - b. Public School Students- Sumter County
 - i. Textbook/materials are delivered to the respective high schools (South Sumter/Wildwood).
The guidance counselor will then distribute materials to students.
 - ii. Contact Sumter County Schools at 352-793-5719 with any questions.
 - c. Private School Students
 - i. Textbooks are obtained at the LSSC bookstore around 2 weeks before classes start.
 - d. Home Education Students
 - i. Textbooks are obtained at the LSSC bookstore around 2 weeks before classes start.
 - e. Charter School Students -
 - i. Please speak to your counselor for textbook pickup instructions as they vary by school.
